Chairman's Report

Such ideas include utilising the School's webpage to enhance visibility of FCGS activity, produce literature about FCGS to improve publicity and help canvas potential businesses to support FCGS.
- 7. In conclusion, it has yet again been a very successful year. The members of FCGS can be very proud of their achievements and their hard work has paid off. This upcoming year will be more challenging than ever; however, we will need to adapt and make sure that we embrace the merger of Chiltern Gate and Maplewood schools and set up a Friends group that can effectively support the two locations. To do this, we need to expand the Friends group and encourage more members to join us and help us provide the best support we can to the school and its pupils.
